CORPORATE AGREEMENT APPLICATION

This Agreement, which governs the terms and conditions of the use of the services of Chicago Limousine Inc., is between the company, and it's cardholder, _____ ("you or "Customer"), as an authorized user of such services, and Chicago Limousine Inc.

This agreement, together with any operating rules, policies, price schedules, or other supplemental documents expressly incorporated herein by reference and published from time to time by Chicago Limousine Inc. (collectively the "Agreement"), constitutes the entire agreement between Chicago Limousine Inc. and you regarding the services of Chicago Limousine Inc., and supersedes all prior agreements between the parties regarding the subject matter of this Agreement. For purposes of this Agreement, "services" are defined as any and all car and limousine services provided by Chicago Limousine Inc. to you, your agent(s), employee(s) or assign(s) either now or in the future. By using the services of Chicago Limousine Inc., you confirm your acceptance of, and agree to be bound by this Agreement.

Charges

- a. You agree to pay all charges for your use of the services of Chicago Limousine Inc. at the prices then in effect. Chicago Limousine Inc. reserve the right to change prices or institute new charges for its services. You are responsible for regularly reviewing, obtaining and confirming such pricing information. Continued use of the services of Chicago Limousine Inc. or non-termination of your account after changes are posted constitutes your acceptance of the prices as charged.
- b. Prices do not include tolls, parking, extra stops, or waiting time, and all charges will be exclusive of a \$3.00 voucher processing fee and a Chauffeur's gratuity of 20% (twenty percent), which will be automatically added to your bill.
- c. You will be invoiced on a bi monthly basis. Payment of your account balance is due upon receipt. You hereby agree to pay all amounts due upon demand. Your account will become past due if such is not paid in full within 30 days of the date of such invoice/bill.
- d. Each time you use the services of Chicago Limousine Inc., or allow or cause the services of Chicago 5 Star Limousine Service to be used, you agree and reaffirm that Chicago Limousine Inc. is authorized to charge your designated credit card.
- e. You agree that Chicago Limousine Inc. may (at its option) accumulate charges incurred during your billing cycle and submit them as one or more aggregate charges during or at the end of each cycle, and that Chicago Limousine Inc. may delay obtaining authorization from your card issuer until submission of the accumulated charge(s). This means that accumulated charges may appear on the statement you receive from your card issuer.

Customer Representations

You represent and warrant that you are at least 18 years of age or, as applicable, the age of majority in the state or province in which you reside, and that you possess the legal right and ability to enter into this Agreement. You agree to be financially responsible for the use of the services of Chicago Limousine Inc. (as well as for use of your account by others, including those persons employed by you and to comply with your responsibilities and obligations as stated in this Agreement.

YOU EXPRESSLY AGREE THAT EXCLUSIVE JURISDICTION FOR ANY CLAIM OR DISPUTE ARISING FROM THE USE OF THE SERVICES OF CHICAGO 5 STAR LIMOUSINE SERVICE IS IN THE ILLINOIS STATE, KANE COUNTY COURT. If any provision of this Agreement is held to be invalid or unenforceable, such provision shall be struck and the remaining provisions shall be enforced. Chicago Limousine Inc.'s failure to act with respect to a breach by you or others does not waive Chicago Limousine Inc. right to act with respect to subsequent or similar breaches. You may not assign or transfer this Agreement or any rights hereunder, and any attempt to the contrary is void. Chicago Limousine Inc. shall not be liable for any delay or failure to perform resulting directly or indirectly from any causes beyond Chicago Limousine Inc.'s reasonable control.
